I. PURPOSE

The Metropolitan Police Department (MPD) recognizes that public intoxication is a public health issue. The policy of MPD is that an intoxicated individual is normally afforded the same consideration as any individual suffering from an illness. The purpose of this general order is to provide procedures for handling calls for service and other interactions with intoxicated individuals who may be eligible for the services at the District of Columbia Stabilization Center (DCSC), which will be offered for intoxicated individuals through a phased approach beginning at the First District. Members will be notified at each phase when other districts are incorporated.

II. PROCEDURES

A. General

- Some intoxicated individuals endanger the safety of themselves, other
 persons, or property. Examples of intoxicated individuals that exhibit the
 level of danger that could justify an intoxication arrest include: intoxicated
 individuals staggering and falling down in on-coming traffic; intoxicated
 individuals caring for a child, where their condition and state of mind could
 cause harm or danger to the child.
- 2. When a member has probable cause that an individual is in violation of DC Official Code § 25 -1001 (Drinking of alcoholic beverage in public place prohibited; intoxication prohibited), the member shall transport the individual to the DCSC in lieu of arrest. This may include incidents where members also have probable cause to believe the subject has committed one or more of the offenses listed in Attachment A (DCSC Eligible Charges).
- 3. Intoxicated individuals **shall not** be transported to DCSC if they are under arrest for offenses other than those specified in DC Official Code § 25-1001, combative or violent, or require immediate medical attention or

- emergency hospitalization for mental observation. Intoxicated individuals endangering the safety of other persons or property may be placed under arrest and processed as any other prisoner, when appropriate.
- 4. Intoxicated individuals reasonably believed to have a mental health condition and pose a danger or threat of danger to themselves shall be assisted pursuant to GO-OPS-308.04 (Interacting with Mental Health Consumers).
- 5. In the event that intoxicated individuals require immediate medical attention, members shall notify the dispatcher to request an ambulance to respond and transport them to the hospital for a medical evaluation.

B. Arrest and Transport

- 1. Members shall handcuff, search, and transport any intoxicated individual taken into custody in the District of Columbia in accordance with GO-PCA-502.01 (Transportation and Searches of Prisoners).
- 2. Members shall conduct a Washington Area Law Enforcement System (WALES)/National Crime Information Center (NCIC) check for any outstanding warrants or missing person reports.
- 3. Small amounts of personal property may be taken to DCSC and turned over to staff members. Members shall not transport personal property that has not been searched for weapons. Any recovered contraband shall be handled in accordance with GO-SPT-601.01 (Recording, Handling, and Disposition of Property Coming into the Custody of the Department).
- 4. Upon arrival at the DCSC, members shall provide any requested information to the staff member taking charge of the intoxicated person, to include what the member witnessed, what is known about the intoxicated individual, where they were encountered, and which substances may have caused the intoxication, if known.
- 5. After transporting intoxicated persons to DCSC, transporting members shall notify the Teletype Unit of intoxicated individuals' identifying information and complete a records management system (RMS) report for "Transport to DCSC" pursuant to GO-OPS-304.10 (Field Contacts, Stops, and Protective Pat Downs).
